APPLICANT PRIVACY POLICY

- Any interviewer or recruiter notes from their interactions with you or with the InfuCare Rx employee that recommended you
- If during the recruitment process you complete a video enabled assessment, we may store the video recordings of the assessment
- Any other information you give us.

Personal data processed if you receive and accept an InfuCare Rx offer of employment, such as your email address, first name, middle name, last name and InfuCare Rx employee number may be used from the date of offer acceptance.

2. For what purposes InfuCare Rx will process your personal data?

In response to your application or your interest about job positions, your information will be used by InfuCare Rx as necessary to:

- Verify your information and conduct relevant and appropriate legally permitted pre-employment and eligibility verification checks, as well as to assess your skills, qualifications, and experience
- Comply with state and federal laws, obligations, and legal requirements
- Communicate with you about InfuCare Rx events, new jobs and career opportunities and the recruitment process including any interviews
- Complete the selection process
- Conduct surveys and research activities with the objective of improving InfuCare Rx's recruiting process
- Perform analysis of our applicant pool in order to better understand who is applying to positions at InfuCare Rx and how to attract top talent

3. For how long will we retain your personal data?
